Commonwealth v. Devante King CR-0013382-2017, J. Mariani--Devante & Brother was

- charged with 1st degree murder. Devante's brother was captured by video shooting the victim. Ultimately, Devante was convicted of Felony murder, however the brothers received the same life sentence. The issue was the constitutionality of the same sentence for different culpability. Counsel & Elbert Gray split representation 50-50.
- Commonwealth v. Hayden-- CP-02-CR-0010092-2019, J. Borkowski—1st murder trial where Miranda rights were waived by a noticeably intoxicated defendant. The jury said it was deadlocked, and Judge Borkowski gave the Allen Charge and Mr. Hayden was convicted of third-degree murder. Counsel & Elbert Gray split representation 50-50.
- Commonwealth v. Day-- CP-02-CR-0010015-2018, J. Howsie—The Commonwealth set out to prove Felony Murder derived from a burglary, Mr. Day, soon after was charged with 4 additional burglaries. Mr. Day sought without counsel to exchange information on a cold murder case of a senior citizen where burglary was the motive. However, after 18 hours of interrogation and becoming drug sick (heroin addict), Mr. Day repeated words of culpability that detectives had provided. Mr. Day provided names of suspects but was the only defendant ever charged. Counsel filed a suppression motion of the confession, on the day of that hearing the Commonwealth offered 10-50 years for the Murder/Burglary case and the additional 4 separate burglaries. The Defendant had a prior record score of 5. The Client had 5 years in the County jail and accepted the Plea offer. Counsel & Elbert Gray split representation 50-50.
- Commonwealth v. Hill-- CP-02-CR: 009072-2020, J. EVASHAVIK-DILUCENT—Mr. Hill was charged with 1st Degree Murder of an infant that was killed by a stray bullet, however not fired by Mr. Hill. The Commonwealth argued transferred intent/Set the circumstances in motion. Mr. Hill was convicted of Manslaughter. Counsel & Elbert Gray split representation 50-50.
- Commonwealth v. Dinkins-- CP-02-CR-0004459-2021, J. Sasinoski—Mr. Dinkins was charge with Robbery with a gun enhancement- The issue was Confirmation Bias and credibility of the witness. Mr. Dinkins was found not guilty. Counsel handled case exclusively.

I live in a vulnerable community, and often represent marginalized people whose central complaint is the process such as not being heard and receiving equitable treatment.

I believe one strength is COURAGE. The practice of law is not for the faint of heart. I like to believe I stand up for what is right, even if it is not popular with public opinion. I argue to uphold the principles of the Constitution, even if those principles lead to a result that doesn't square with my personal values.

I am OPEN-MINDED, persuadable and love listening to good arguments or legal theory. I am patient and wait for all the facts before forming any opinion.

I have DIVERSE EXPERIENCE. I have over 15 years' experience in law enforcement, about 10 years as a Law Clerk and almost 20 years in Private Practice. I have been an Adjunct Law Professor for over four years. I believe all of those roles and experiences provide a 360-degree view and bring COMMON SENSE to the job as Judge.

Marijuana, Disorderly Conduct, Retail Theft, and Lewd Behavior because of public urination. I assist clients with clearing their records so they might get jobs, some with the Court of Common Pleas, and Paralegals at large law firms. I have assisted quite a few law students who need to take the Bar as well as clients who want to enter the Police Academy. I've assisted law students of color with bar preparation. Finally, I have spoken many times at Pittsburgh Obama High School for career day.
